Effective email archiving reduces IT, legal and regulatory costs while maintaining compliance with regulations



The Challenge

Healthcare providers have the same challenges as any business. When it comes to message archiving, they have the added challenge of meeting HIPAA requirements. Email, and in many cases instant messages (IM), have become the prevalent means of communicating for healthcare providers. Communications have rapidly extended to their patients from the organization and from doctors as well. Healthcare providers need to also take special care of the personal confidential information they maintain on their patients.

Other challenges include legal discovery which is the legal process of producing documents during any litigation. Orderly records management is crucial to respond quickly and accurately. IT also has challenges with storage limits on their email servers and data leak protection (DLP) to control the security of information is a also a requirement.

Finally, there is a responsibility to make sure that these records produced during litigation are not purged from their systems while the case is still open. A litigation hold capability is paramount to avoid losing records that may have reached the end of their scheduled life.

- Healthcare providers are faced with these specific and general regulations:
- Records management of electronic communications—email, instant messages and more
 - This includes the retention and orderly destruction of information and legal holds in compliance with specific regulations on their industry
- Producing messages as evidence for a legal or regulatory discovery inquiry
- Protecting Patient confidentiality

The Health Insurance Portability and Accountability Act, or "HIPAA", was passed by the federal government in 1996 and has wide-reaching implications on a number of healthcare service providers including hospitals, doctors, health insurance and life insurance firms, as well as long-term care facilities, medical billing companies and any business which maintains health records.

This regulation protects the privacy of an individual's medical information by requiring that healthcare providers deploy security measures to protect electronic health records. It also orders organizations to set up a contingency plan to address emergencies if systems that store medical information are damaged.


The Facts


